**NOTICE OF PLANNING COMMISSION PUBLIC HEARING ON APPLICATION FOR FUTURE  
LAND USE PLAN MAP AMENDMENT AND ZONING MAP AMENDMENT (REZONING)**

TO: THE RESIDENTS AND PROPERTY OWNERS OF THE TOWNSHIP OF SCHOOLCRAFT, KALAMAZOO COUNTY, MICHIGAN, AND ANY OTHER INTERESTED PERSONS:

PLEASE TAKE NOTICE the Schoolcraft Township Zoning Board Planning Commission will hold a public hearing at its regular meeting on Monday, June 5, 2017, which begins at 6:00 p.m. at the Schoolcraft Township Hall located at 50 East VW Avenue within the Township of Schoolcraft, Kalamazoo County, Michigan. The public hearing will be held on the following rezoning application:

The application of Jerry D. Lewis to amend the Zoning Map and the Future Land Use Map Land so as to rezone a parcel of approximately 26.4 acres from RR Rural Residential to the US 131 Corridor Business District. The property proposed to be rezoned is commonly known as 11607 South Shaver Road, (parcel 3914-06-430-039), and is currently zoned Rural Residential. The property proposed for rezoning on the Future Land Use Map is Rural Preservation Designation and Manufactured Home Park Designation.

The Schoolcraft Township Zoning Ordinance and Map, and the variance application materials, may be examined by contacting the Township Clerk, and may also be examined at the hearing/meeting.

The exact location and legal description of the property proposed for rezoning, and the Schoolcraft Township Zoning Ordinance/Map and Master Plan may be examined by contacting the Schoolcraft Township Clerk at the Township Hall during regular business hours on regular business days maintained by the Township offices from and after the publication of the Notice and until and including the day of the hearing/meeting, and further may be examined at the hearing/meeting.

Written comments regarding the above-referenced matters may be submitted to the Township Clerk prior to the hearing/meeting, and may also be submitted to the Planning Commission at the hearing/meeting.

The Planning Commission reserves the right to modify any of the proposed amendments of the Zoning Ordinance/Map/Master Plan, as acceptable, at or following the hearing/meeting and to make its recommendations accordingly to the Township Board.

Schoolcraft Township will provide necessary reasonable auxiliary aids and services at the hearing/meeting to individuals with disabilities, such as signers for the hearing impaired and audiotapes of printed materials being considered, upon reasonable notice to the Township. Individuals with disabilities requiring auxiliary aids or services should contact the Township Clerk.
