No new business items were discussed.

### **OLD BUSINESS**

a. Ag Zoning ..next steps, RR Zoning preliminary concepts

The Commission reviewed the events of the December 6, 2010, meeting involving Township residents and landowners and felt that moving to an official public hearing of the proposed new Ag 1 and Ag 2 zoning ordinance language and map was warranted.

A question regarding the Subdivision Control Ordinance (#24) was discussed. Specifically, can the Subdivision Control Ordinance, in conjunction with Section XX (as now written) be used to allow platting of parcels in the new Ag1 and Ag 2 zones as an alternate route to residential development? The Commission requested that the issue be forwarded to Attorney Rolfe and that he assure that the overall ordinance language <u>not allow</u> such development.

A motion to hold a public hearing at our February meeting on the proposed new Ag 1 and Ag 2 zoning ordinance language and map, with any changes which might result from deliberations on the Subdivision Control Ordinance discussed above, was made by Ken Hovenkamp, with support from Len Jaworski.

#### **Motion carried 7-0**

The Commission next reviewed the ten points provided by Attorney Rolfe for consideration of updating the Rural Residential zoning ordinance language to better reflect the intent of our Master Plan. Much of the discussion centered on base and bonus density concepts. As discussion progressed, Commissioners confirmed that, as in the Ag classifications, we want to preserve rural character, open space, and natural resources in Rural Residential zones. Chairman Visel will forward discussion point feedback to Attorney Rolfe for integration into draft language.

Commissioners were directed to the Township Board Minutes included in the packet for updates on Board Activities.
